### Options for State Medicaid Programs During COVID-19 Emergency

On March 13, 2020, a national emergency was declared, in accordance with the Stafford Act, for the entire United States in response to the COVID-19 crisis. Previously, on Jan. 31, 2020, then U.S. Department of Health and Human Services Secretary Azar declared a public health emergency for the entire United States in accordance with the Public Health Services Act.

### Medicaid Options for States During COVID-19: Considerations for Children and Youth with Special Health Care Needs

This fact sheet explores Medicaid policy options for states to meet the needs of children and youth with special health care needs during the public health emergency and discusses how future rollbacks of public health emergency modifications may affect children and youth with special health care needs populations.

This report from the National Academy for State Health Policy and the Duke Margolis Center for Health Policy explores how states are tackling the challenge of identifying gaps in vaccine access among their Medicaid populations and provides examples of promising strategies to improve COVID-19 vaccination rates among Medicaid beneficiaries.

### How Can States Improve COVID-19 Vaccination Rates in Their Medicaid Programs?

With lower COVID-19 vaccination rates than the general population, people enrolled in Medicaid have higher rates of infection, hospitalization, and death from COVID-19. States and health plans can employ promising strategies, like using data to monitor progress and reducing barriers to vaccination, to increase COVID-19 vaccination rates among Medicaid beneficiaries.

### Lessons Learned from the Early COVID-19 Vaccine Rollout

Three interrelated challenges are impacting the early rollout of COVID-19 vaccines: vaccine scarcity, distribution, and communication. Researchers at the Georgia Health Policy Center examined top-performing states to identify innovative practices and policies.

### COVID-19 Vaccine Rollout in Rural Communities: Challenges, Innovations, and Unmet Needs

This is a summary of learnings around local rollout challenges, stories of success and innovation for overcoming barriers to vaccine rollout, and a summary of unmet local needs.
